MERCHANDISE TRADE June 2014 quarter

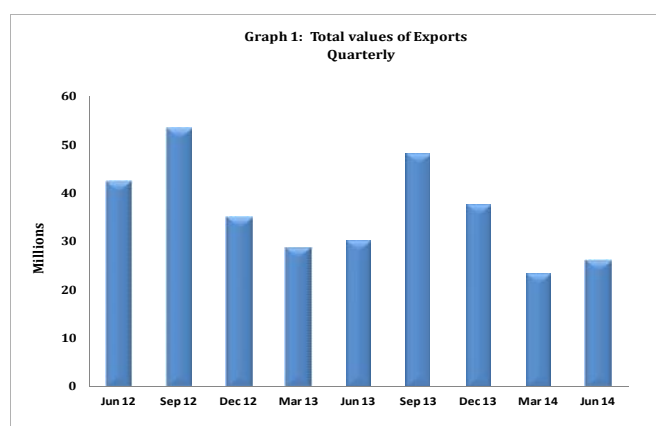
Key findings

For the June 2014 quarter compared to the March 2014 quarter:

- Exports rose \$2.7 million (11.5 percent) to \$26 million
- Ignition wiring sets led this rise, up \$3.6 million
- Exports to New Zealand rose \$3.7 million to \$6.4 million, and to Australia rose \$1.8 to \$14.7 million
- Imports rose \$15 million (7.5 percent) to \$217 million
- Imports from Singapore fell \$9.7 million to \$54.6 million
- There was a trade deficit of \$191 million

Value of Exports

The total value of exports for the June 2014 quarter increased 11.5 percent (\$2.7 million) when compared to the March 2014 quarter. In comparison with the June 2013 quarter, the current value of exports decreased 14 percent (\$4.2 million). At \$26 million, domestic exports were valued at \$14.6 million and re-exports were valued at \$11.4 million. (See table 1 and graph 1)

The four quarters ending June 2014 showed a decrease of 8.1 percent (\$12 million) in the total value of exports compared to the four quarters ending June 2013.

Top export commodities¹

Petroleum oils² other than crude oil continued to be the largest share of all commodities exported in the June 2014 quarter contributing \$10.7 million (41.4 percent of total). This value was 32.0 percent (\$2.6 million) and 14.0 percent (\$1.3 million) higher than the March 2014 quarter and the June 2013 quarter respectively. Ignition wiring sets and other wiring sets for vehicles followed in increasing value, contributing \$9.3 million (35.7 percent of total value). This value was 64.3 percent (\$3.6 million) higher than March 2014 quarter but 23.7 percent (\$2.9 million) lower than the June 2013 quarter.

Fruit juices is third with a total of \$953 thousand (3.7 percent of total) which decreased by 12.2 percent from the March 2014 quarter. Of the total, 97.6 percent was exported to USA.

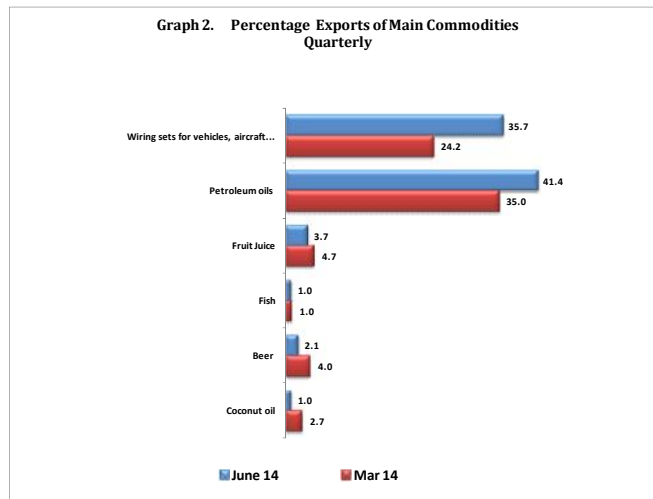
Fish exports have recovered from its previous drop contributing \$832 thousand (3.2 percent) to total exports in the quarter under review. This value twice the March 2014 quarter but 74.6 percent lower than the June 2013 quarter. New Zealand was the main country of destination contributing to 97.4 percent while American Samoa represented the 2.6 percent of total fish exported.

Beer is fifth, its value decreased to \$556 thousand (2.0 percent of total exports) from the previous quarter. Exports to New Zealand made up 57 percent of total value and the remaining 43 percent was exported to American Samoa.

Coconut oil accounted for 1.0 percent share in which 76.6 percent was exported to Australia while New Zealand and American Samoa represented 22.7 percent and 0.7 percent respectively. The rest of commodities accounted for less than 1 percent each with a combined total of 6.3 percent. (See table 2 and graph 2)

Country of Destination for Exports

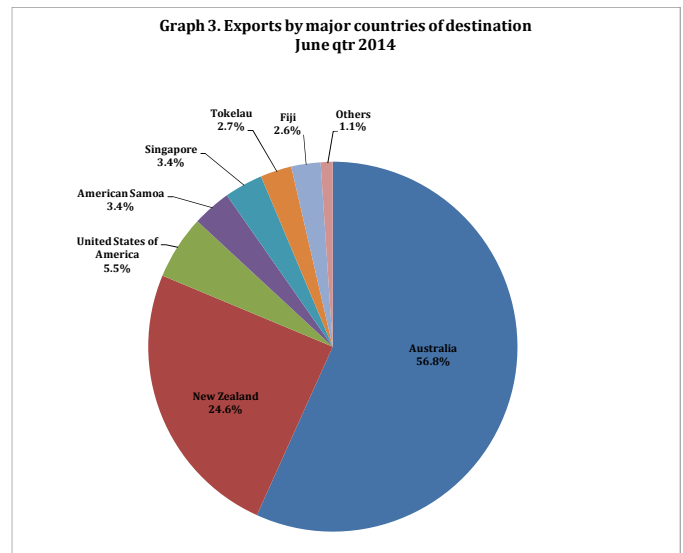
Australia maintained the largest export market in the June 2014 quarter with its value increasing to \$14.7 million (56.8 percent of all exports) from \$13 million in the March 2014 quarter. In comparison with the June 2013 quarter, the current value of exports to Australia decreased 7.6 percent. The increase was mainly driven by the export of machinery and mechanical & electrical appliances and parts thereof.

New Zealand followed with a total of \$6.4 million (24.6 percent of total). This value was twice the March 2014 quarter and 17.5 percent lower than the June 2013 quarter. Largely responsible for the rise in the current value of exports to New Zealand were the increases in the values of 'petroleum' and 'fish' exported in the June 2014 quarter.

USA is third with a total of \$1.4 million (5.5 percent of total) which decreased by 23.3 percent from the March 2014 quarter. American Samoa and Singapore contributed 3.4 percent each of the total exports while Tokelau and Fiji represented 2.7 percent and 2.6 percent respectively. Other countries of destination represented 1.1 percent of total exports. (See table 4 and graph 3)

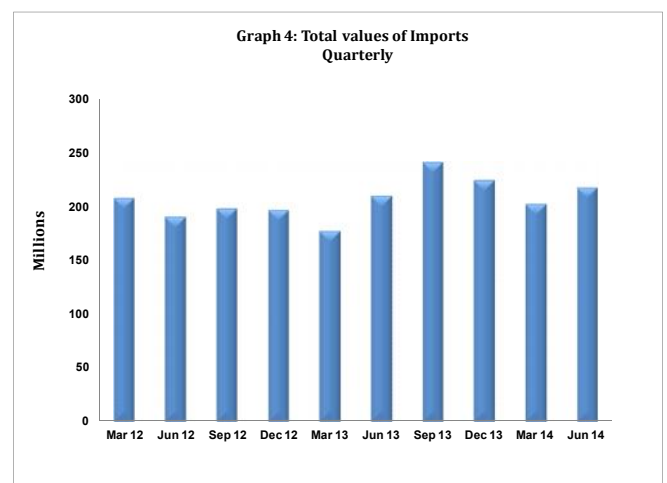

Value of Imports

The total value of imports for the June 2014 quarter increased 7.5 percent (\$15 million) when compared to the March 2014 quarter. In comparison with the June 2013 quarter, the current value of imports increased 3.4 percent (\$7.2 million). (See table 1 and graph 4)

The four quarters ending June 2014 showed an increase of 13.1 percent (\$102.7 million) in the

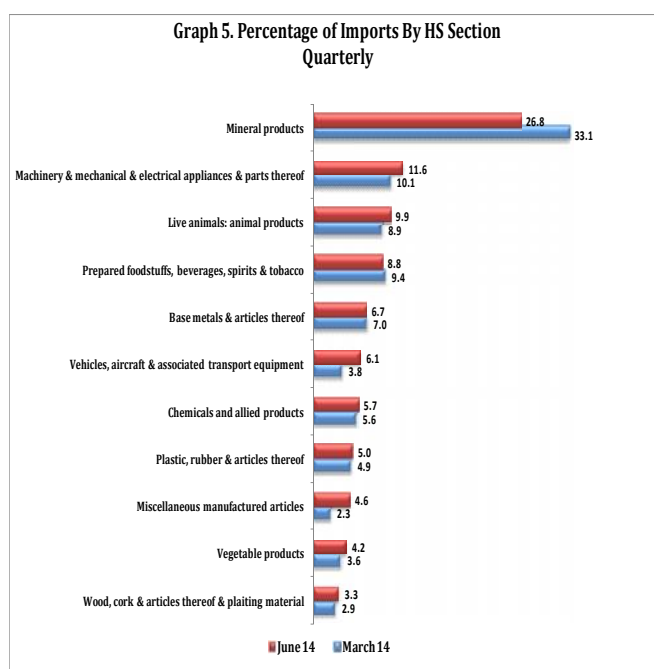
total value of imports compared to the four quarters ending June 2013.

Composition of Imports

Mineral products remained the main commodity group imported in the quarter under review despite the decrease in its value, accounting for 26.8 percent (58 million) of total imports. In comparison with the March 2014 quarter, the current value decreased 13 percent.

Machinery and mechanical, electrical appliances and parts thereof accounted for 11.6 percent (\$25 million) of the total value. When compared to the March 2014, the current value increased 24 percent (\$4.8 million).

Live animals, animal products is third, its value increased to \$21.4 million (9.9 percent of total imports) from the previous quarter. The increase is due to higher values of chicken meats imported in the June 2014 quarter. Prepared foodstuffs, beverages, spirits & tobacco accounted for 8.8 percent (\$19.1 million) (up 2 percent from previous quarter). Base metals & articles thereof accounted for 6.7 percent (up 4 percent from previous quarter). Vehicles, aircraft & associated transport equipment recorded a total value of \$13 million (6 percent of total imports) while Chemicals & allied products and plastic, rubber & articles thereof accounted for 5.7 percent and 5.0 percent shares respectively. The remaining HS Sections accounted for less than 5 percent each with a combined total of 19.4 percent. (See table 5 and graph 5)

Imports by Broad Economic Categories

The values for the three main broad economic categories all rose in the June quarter, compared with the March 2014 quarter.

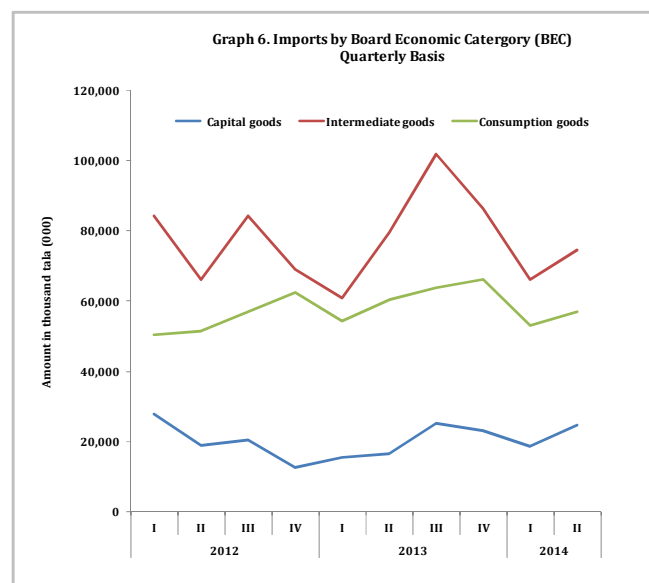
Capital goods rose 32.5 percent to \$24.7 million from the March 2014 quarter. Machinery and plant goods rose \$4.3 million (28.1 percent) due to the imports of electrical machineries.

Transport equipments increased \$1.7 million (52.5 percent), led by vehicles.

Intermediate goods also increased contributing 12.6 percent of total imports. The increase was led by industrial processed goods; up \$4.5 million.

Consumption goods rose \$3 million (7.2 percent), due to processed food and beverages goods, up \$4 million.

In **other categories** of goods, passenger motor cars rose \$3.8 million while petrol and avgas fell \$8.5 million. (See table 6 and graph 6)

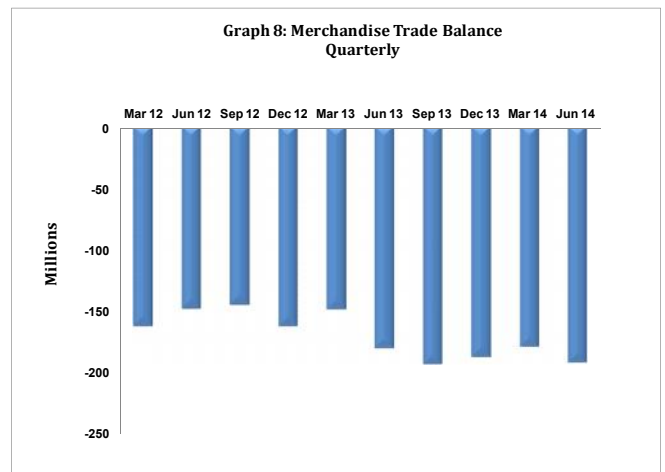
Major Source Markets of Imports

By major source markets of imports, Singapore remained the leading source market of imports in the June 2014 quarter with its value decreasing to \$54.6 million (25.2 percent of all imports) from \$64.3 million in the March 2014 quarter. When compared to the June 2013 quarter, the current value increased 5 percent. New Zealand followed with a total of \$53.8 million (24.8 percent of total imports). This value was 3.7 percent higher than the March 2014 quarter but 12.5 percent lower than the June 2013 quarter. Imports from China had a total value of \$34.2

million (15.7 percent of total imports) increasing from \$14.6 million in the March 2014 quarter. Electrical machinery and equipment parts thereof and furniture were the main drivers for the rise of imports from China. USA represented 10.5 percent (\$22.8 million) of total imports; up 8.6 percent from the March 2014 quarter. Australia contributed 7.7 percent (\$16.6 million); down 2.1 percent from the March 2014 quarter. Fiji represented 5.3 percent (\$11.5 million) while Japan contributed 3.4 percent of total. Other countries accounted for less than 3 percent each with a combined total of 7.4 percent. (See table 7 graph 7).

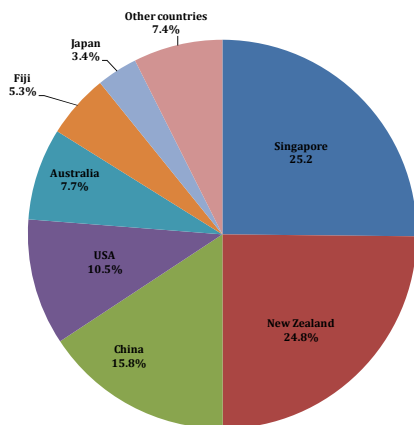
Technical Notes

Merchandise Trade Balance

In the June 2014 quarter, the value of imports (\$217 million) exceeded that of exports (26 million), resulting in a trade deficit of \$191 million. This value was 6.9 percent and 6.3 percent higher than the levels of the March 2014 quarter and the June 2013 quarter respectively. (See table 1 and graph 8)
