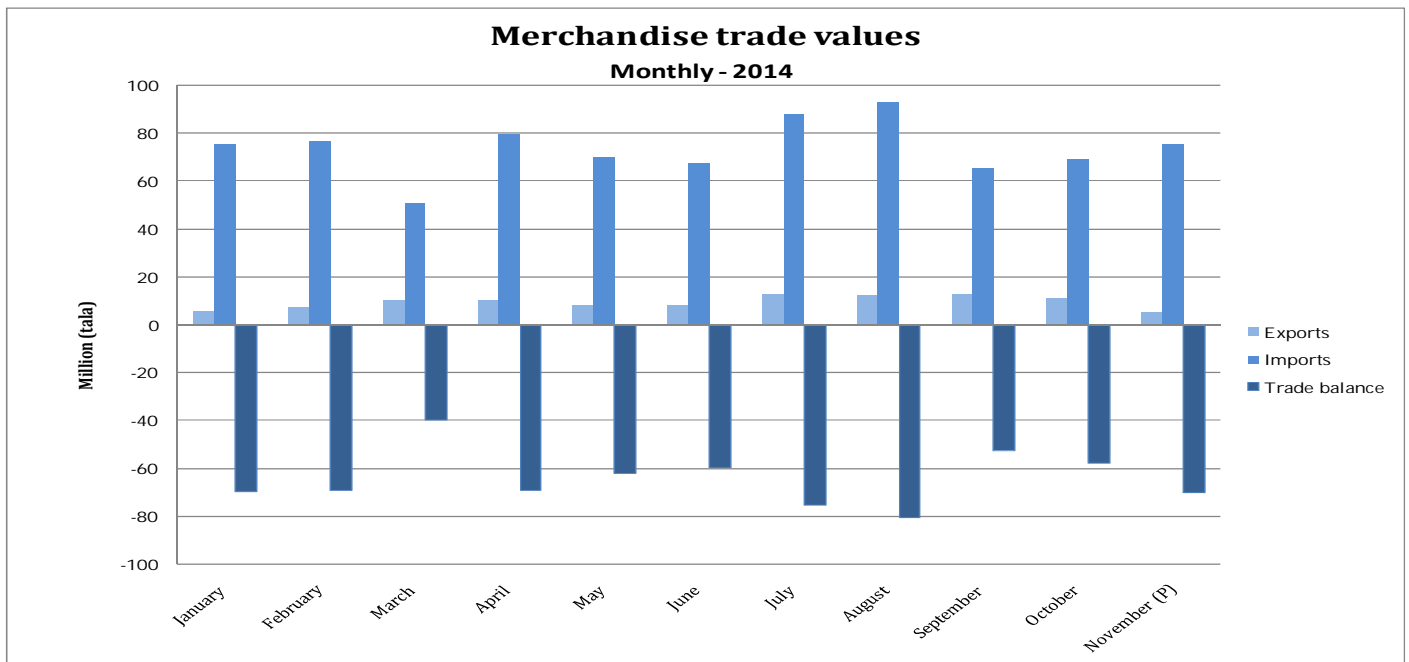

Merchandise Trade November 2014

Key facts for November 2014 compared to October 2014

- Exports fell \$6.4 million (57.4 percent) to \$4.8 million.
- Ignition wiring sets recorded the largest decrease (down \$5.0 million)
- Exports to Australia fell \$5.5 million to \$1.8 million and to New Zealand fell \$626.6 thousand to \$1.4 million
- Imports rose \$6.0 million (8.7 percent) to \$74.9 million.
- Petroleum products recorded the largest increase (up \$3.8 million); led by distillate fuel (up \$2.7 million)
- Imports from Singapore rose \$2.7 million to \$18.6 million and from Australia rose \$1.5 million to \$7.9 million while imports from USA decreased \$992 thousand to \$8 million
- There was a trade deficit of \$70 million
