### MERCHANDISE TRADE December 2014 quarter

#### Key findings

For the December 2014 quarter compared with the September 2014 quarter:

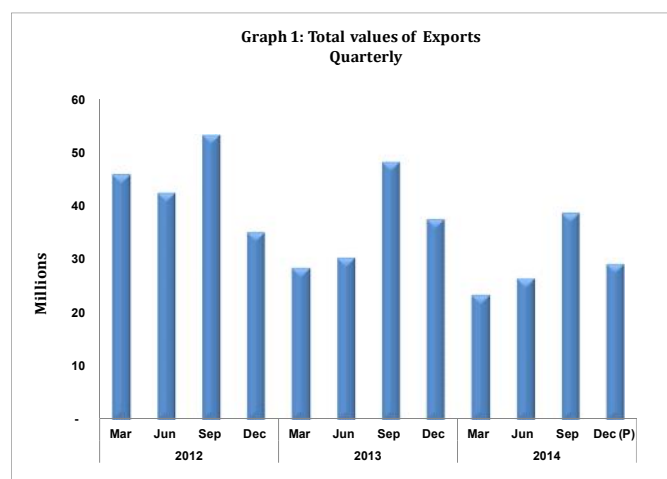
- Exports value fell 24.7 percent \$29 million.
- Ignition wiring sets exports recorded the largest decrease; down \$7.8 million.
- Exports to Australia fell 36.4 percent to \$15.7 million, and to New Zealand fell 18 percent to \$6 million
- Imports value fell 7.5 percent to \$228.4 million
- Machinery & mechanical & electrical appliances & parts thereof imports recorded the largest decrease; down \$15.3 million
- Imports from New Zealand fell 29.9 million to \$59.5 million.
- Trade deficit fell 4 percent to \$199.3 million

#### Overview

#### Value of Exports

The total value of exports in the December 2014 quarter decreased 24.7 percent (\$9.5 million) to \$29.1 million from the September 2014 quarter. In comparison with the December 2013 quarter, the current value of exports decreased 22.2 percent (\$8.3 million). Mainly responsible for the decrease was lower values of ignition wiring sets exported in the quarter under review.

At \$29.1 million, domestic exports were valued at \$19.8 million and re-exports were valued at \$9.3 million. (See table 1 and graph 1)

The four quarters ending December 2014 showed a decrease of 18.5 percent (\$26.7 million) in the total value of exports compared to the four quarters ending December 2013.

#### Top export commodities<sup>1</sup>

Ignition wiring sets and other wiring sets for vehicles continued to be the largest share of all commodities exported in the December 2014 quarter despite the decrease in its value, contributing \$9.5 million (32.7 percent of total exports). This value was 45.2 percent (\$7.8 million) and 32.6 percent (\$4.6 million) lower than the September 2014 quarter and the December 2013 quarter respectively.

Exports of petroleum oils<sup>2</sup> other than crude oil followed with a total of \$8.6 million (29.5 percent of total exports). This value was 28.0 percent (\$3.3 million) and 5.9 percent (\$538 thousand) lower than the September 2013 quarter and the December 2013 quarter respectively.

Beer exports was third with a total of \$2.8 million (9.5 percent of total exports) which increased by 77.4 percent (\$1.2 million) from the September 2014 quarter. The rise was mainly due to higher values of beer exported to American Samoa. In comparison with the December 2013, the current value of beer exports decreased 59.5 percent (\$4.1 million).

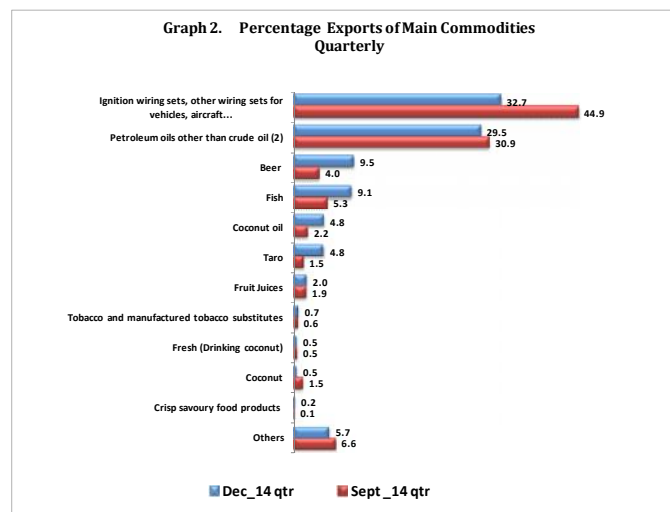
Fish exports was fourth, representing 9.1 percent (\$2.7 million) of total value, increasing 30.6 percent from the September 2014 quarter and 31.6 percent from the December 2013 quarter.

Coconut oil and taro exports accounted for 4.8 percent (\$1.4 million) each of total value. The current value coconut oil was 62.1 percent higher than September 2014 quarter, reflecting higher values of coconut oil exported to Australia (up 83 percent). In comparison with the December 2013 quarter, the current value was 20 times higher than the December 2013 quarter. The current value of taro was twice its value in the September 2014 quarter and 3 times higher than the December 2013 quarter, driven by higher values of exports to New Zealand (up \$775 thousand) and American Samoa (up \$17.6 thousand).

Fruit juices exports accounted for 2.0 percent (\$596 thousand) of total value, decreasing 20.6 percent and 34.1 percent from the September 2014 quarter and the December 2013 quarter respectively.

Tobacco exports accounted for 0.7 percent of total value (\$215 thousand), decreasing 8.6 percent from the September 2014 quarter and 48.1 percent from the December 2013 quarter.

Exports of coconut and drinking coconut accounted for 0.5 percent each while crisp savoury food products represented 0.2 percent of total value. Relatively lower share was recorded for natural mineral water and no desiccated coconut exported while other commodities accounted for 5.7 percent share. (See table 2 and graph 2)

### **Country of Destination for Exports**

Australia maintained the largest export market in the December 2014 quarter with its value decreasing to \$15.6 million (53.7 percent of all exports) from \$24.6 million in the September 2014 quarter. In comparison with the December 2013 quarter, the current value of exports to Australia decreased 17.4 percent. Largely responsible for the fall in the current value of exports to Australia was the decrease in the value of ignition wiring sets and other wiring sets for vehicles exported in the December 2014 quarter.

New Zealand followed with a total of \$6.1 million (20.0 percent of total). This value was 16.7 percent lower than the September 2014 quarter but 33.2 percent higher than the December 2013 quarter.

American Samoa was third with a total of \$3.7 million (12.6 percent of total) which was twice its value in the September 2014 quarter, reflecting higher values of beer and taro exported in the quarter under review. In comparison with the December 2013 quarter, the current value of exports to American Samoa decreased 36.2 percent.

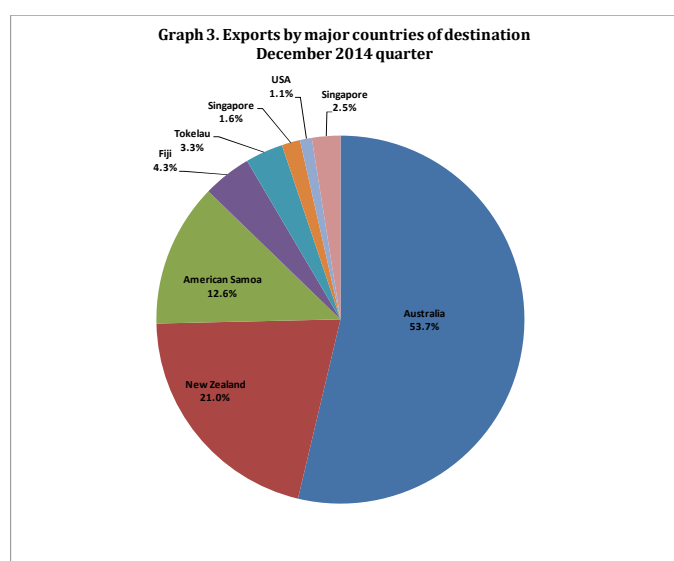
Exports to Fiji contributed 4.3 percent (\$1.2 million) of total exports, increasing 17.7 percent from the September 2014 quarter and 1.0 percent from the December 2013 quarter.

Exports to Tokelau represented 3.3 percent (\$964 thousand) of the total exports, increasing 47.0 percent from the September 2014 quarter

but fell 72.7 percent when compared to the December 2013 quarter.

Exports to USA contributed 1.6 percent of total value, decreasing 24.7 percent from the September 2014 quarter and 40.4 percent from the December 2013 quarter.

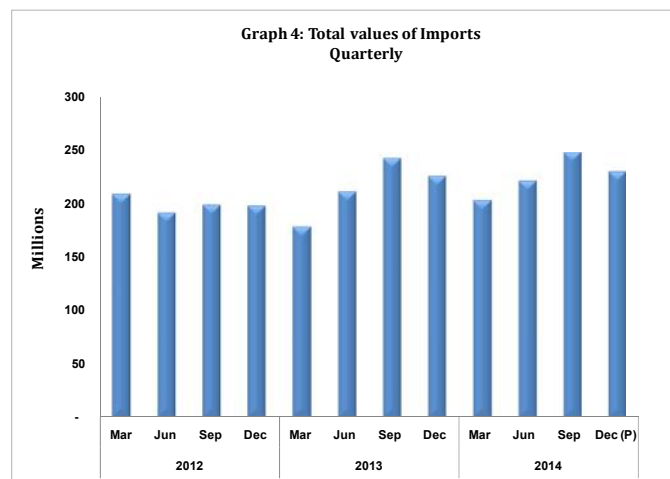
Exports to Singapore represented 1.1 percent of total value, decreasing 84.2 percent and 35 percent from the September 2014 quarter and the December 2013 quarter respectively with petroleum products the main driver for the decrease while other countries of destination accounted for less than 1 percent each with a combined total of 2.5 percent. ### Value of Imports

The total value of imports for the December 2014 quarter decreased 7.5 percent (\$18.5 million) when compared to the September 2014 quarter. The decrease was mainly due to lower values of machinery & mechanical & electrical appliances & parts thereof (down \$15.3 million). In comparison with the December 2013 quarter, the current value of imports increased 1.9 percent (\$4.2 million). (See table 1 and graph 4)

The four quarters ending December 2014 showed an increase of 5.2 percent (\$44 million) in the total value of imports compared to the four quarters ending December 2013.

### Composition of Imports

Mineral products maintained the largest share of all commodity groups imported in the December 2014 quarter, despite the decrease in its value, contributing 23.1 percent (\$52.7 million) of total imports. This value was 5.3 percent lower than the September 2014 but 5.6 percent higher than the December 2013 quarter.

Imports of live animal, animal products and prepared foodstuffs, beverages, spirits & tobacco imports accounted for 10.5 percent (\$23.9 million) each of total value. The current value of live animals, animal products was 1.0 percent and 3.5 percent lower than the September 2014 quarter and the December 2013 quarter respectively while the current value of prepared foodstuff, beverages, spirits & tobacco was 4.1 percent and 6.5 percent lower than the September 2014 quarter and the December 2013 quarter in that order.

Imports of machinery and mechanical, electrical appliances and parts thereof accounted for 8.6 percent (\$19.7 million) of total value, decreasing 43.6 percent from the September 2014 quarter and 31.7 percent from the December 2013 quarter (\$9.2 million).

Base metals & articles thereof imports accounted for 7.8 percent (\$17.7 million) of total value, increasing 8.1 percent from the September 2014 quarter and 9.4 percent from the December 2013 quarter.

Chemicals & allied products imports accounted for 6.6 percent of total value (\$15.1 million), increasing 1.2 percent from the September 2014 quarter and 29.1 percent from the December 2013 quarter.

Imports of vehicles, aircraft & associated transport equipments contributed 6.1 percent (\$13.9 million) of total value, decreasing 1.4 percent from the September 2014 quarter but rose 34.9 percent when compared with the December 2013 quarter.

Plastics, rubber & articles thereof imports accounted for 5.4 percent (\$12.3 million), increasing 5.4 percent from the September 2014 quarter but fell 3.4 percent when compared with the December 2013 quarter.

Imports of vegetable products accounted for 4.5 percent, decreasing 1.1 percent and 3.9 percent from the September 2014 quarter and the December 2013 quarter respectively.

Imports of miscellaneous manufactured articles products accounted for 4.1 percent (\$9.5 million) of total value, increasing 13.4 percent and 74.4 percent from the September 2014 quarter and the December 2013 quarter in that order.

Wood, cork & articles thereof & plaiting material imports accounted for 3.8 percent (\$8.6 million) of total value, decreasing 5.5 percent from the September 2014 quarter but 7.5 percent higher when compared with the December 2013 quarter. The remaining HS Sections accounted for less than 3 percent each with a combined total of 9.2 percent. (See table 5 and graph 5)

### **Imports by Broad Economic Categories**

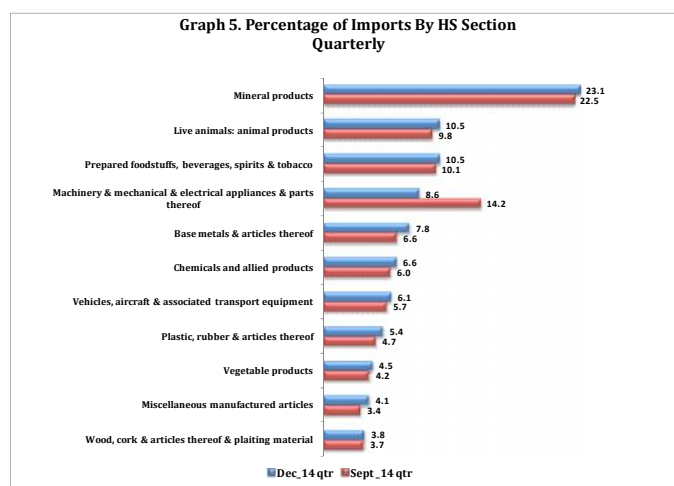
The values for the three main broad economic categories all decreased in the December 2014 quarter, compared with the September 2014 quarter.

Imports of capital goods contributed 8.7 percent (\$19.8 million) of total imports, decreasing 34.8 percent from the September 2014 quarter and 14.5 percent from the December 2013 quarter. At \$19.8 million, machinery and plant goods were valued at \$12.1 million, decreasing 45.4 percent from the September 2014 quarter while transport equipments were valued at \$7.7 million which decreased by 5.9 percent from the September 2014 quarter.

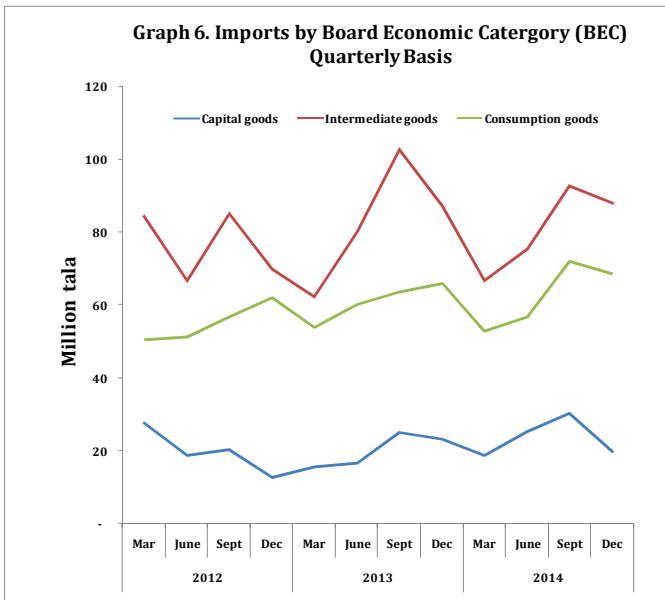
Imports of intermediate goods also decreased contributing 38.6 percent of total imports, mainly driven by lower values of parts and accessories of capital goods (down \$7.7 million). In comparison with the December 2013 quarter, the current value of intermediate goods decreased 1.0 percent.

Consumption goods imports recorded a total value of \$68.6 million, decreasing 4.7 percent from the September 2014 quarter but increased 4.1 percent when compared with the December 2013 quarter. The decrease was mainly due to lower values of food and beverages, primary, mainly for home consumption (down \$1.3 million).

In other categories of goods, passenger motor cars imports fell 12.9 percent (\$557 thousand) while petrol and avgas imports fell 1.0 percent (\$398 thousand) from the September 2014 quarter. (See table 6 and graph 6)

**Major Source Markets of Imports**

By major source markets of imports, New Zealand became the leading source market of imports in the December 2014 quarter with its value decreasing to \$59.5 million (26.1 percent of all imports) from \$84.8 million in the September 2014 quarter. When compared to the December 2013 quarter, the current value decreased 17 percent.

Singapore followed with a total of \$50.1 million (21.9 percent of total imports). This value was 1.2 percent and 8.7 percent higher than the September 2014 quarter and the December 2013 quarter respectively.

Imports from China had a total value of \$24.9 million (10.9 percent of total imports), increasing 23.8 percent from the September 2014 quarter and 22.6 percent from the December 2013 quarter.

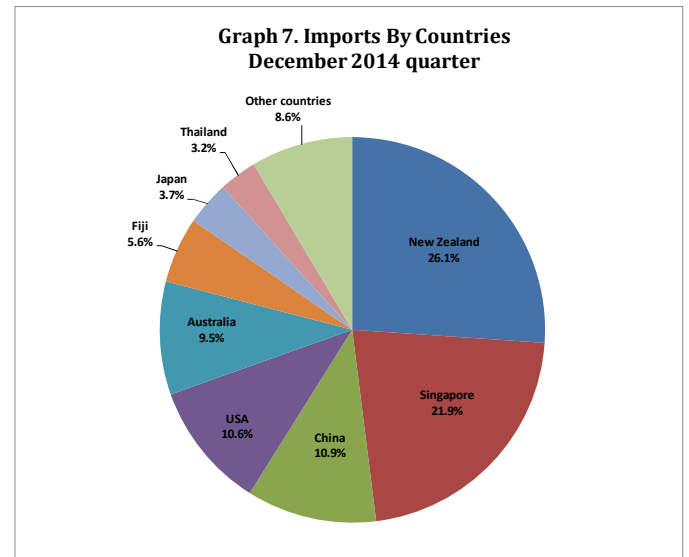
USA represented 10.6 percent (\$24.3 million) of total imports, increasing from 9.7 percent in the September but fell 15.4 percent when compared with the December 2013 quarter.

Australia contributed 9.5 percent (\$21.6 million) of total imports, decreasing 9.0 percent from the September but rose 43.1 percent when compared with the December 2013 quarter.

Fiji represented 5.6 percent of total value (\$12.7 million), decreasing 12.1 percent from the September 2014 but rose 21.0 percent when compared with the December 2013 quarter.

Japan contributed 3.7 percent (\$8.4 million) of total value, decreasing 28.2 percent and 1.6 percent in the September 2014 quarter and the December 2013 quarter respectively.

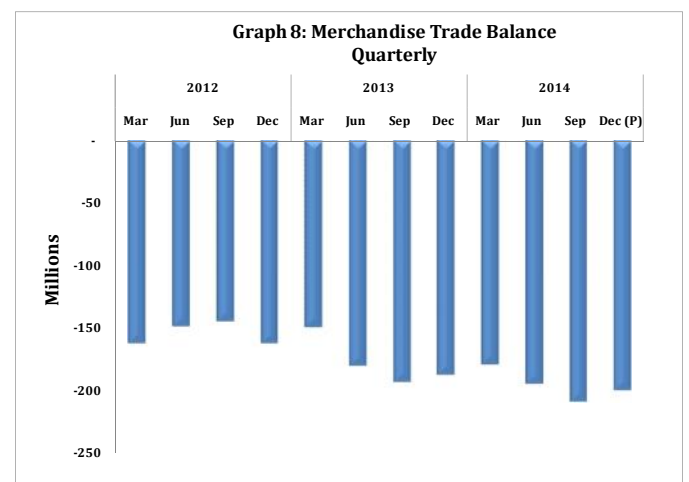
Thailand contributed 3.2 percent of total value (\$7.2 million), increasing 62.2 percent from the September 2014 quarter and 27.3 percent from the December 2013 quarter. Other countries accounted for less than 3 percent each with a combined total of 8.6 percent. (See table 7 graph 7).

**Merchandise Trade Balance**

In the December 2014 quarter, the value of imports (\$228.4 million) exceeded that of exports (\$29.1 million), resulting in a trade deficit of \$199.3 million. This value was 4.3 percent lower than the September 2014 quarter but 6.7 percent higher than the December 2013 quarter. (See table 1 and graph 8)

The main source of imports and exports data comes from the administrative document, a completed customs form (Single Administrative data) required to be filled in by importers and exporters or customs agents when clearing merchandise inward and outward through the Ministry for Revenue (Custom Department)

The next quarterly Merchandise trade report is expected to be available on June 3<sup>rd</sup> 2015.
