### Merchandise Trade June 2016

#### Highlights of the month

#### Exports

- Exports<sup>1</sup> were valued at \$12.4 million, decreasing 10.6 percent from May 2016
- Food & live animal exports recorded the largest decrease (down \$2.8 million), but remained the top commodity groups exported during June 2016, representing 38.4 percent of total exports value. The decrease was mainly due to lower values of fish.
- Exports to American Samoa decreased by \$1.4 million and to New Zealand decreased by \$1.1 million while exports to Australia increased by \$1.2 thousand from May 2016.

#### Imports

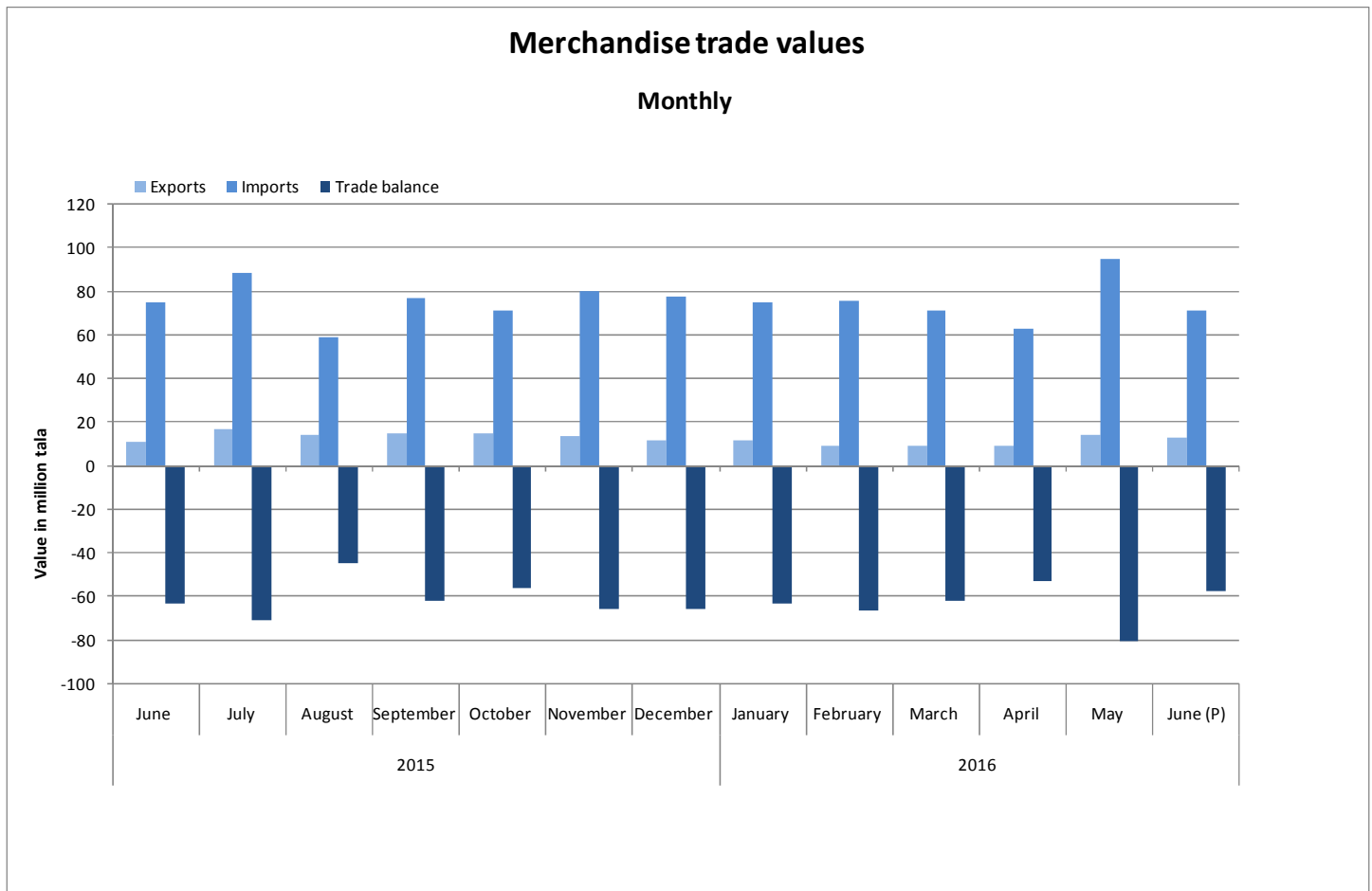
- Imports were valued at \$70.5 million, decreasing 25.3 percent from May 2016.
- Food and Live animals imports recorded the largest decrease (down \$6.9 million) but maintained the largest share of all commodity groups imported during June 2016, representing 24.1 percent of total imports value.
- Imports from Fiji, China, Australia Thailand, New Zealand and Japan recorded large decreases from May 2016.

#### Trade Balance

- The value of imports (\$70.5 million) exceeded that of exports (\$12.4 million), resulting in a trade deficit of \$58.1 million.
