MERCHANDISE TRADE June 2016 quarter

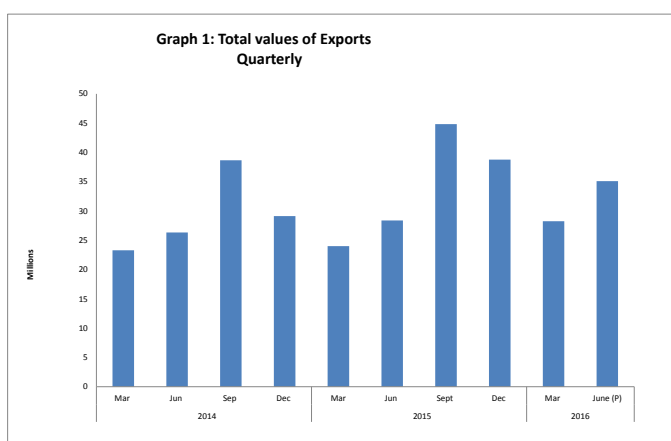
Highlights of the quarter

- Exports value rose 24.2 percent to \$35.1 million from the March 2016 quarter.
- Imports value rose 2.8 percent to \$227 million from the March 2016 quarter.
- There was a trade deficit of \$192 million.

Overview

Value of Exports

In the June 2016 quarter, exports were valued at \$35.1 million. This value was 24.2 percent and 23.6 percent higher than the previous quarter and the corresponding quarter of 2015 respectively. Mainly responsible for the rise were higher values of petroleum oils, ignition wiring and fish exports. (See table 1, 2, 3 and graph 1)

The four quarters ending June 2016 showed a 22.3 percent increase in the total value of exports when compared with the four quarters ending June 2015.

Top export commodities¹

In the June 2016 quarter, fish exports maintained the top commodities exported, valued at \$10.2 million, representing 28.9 percent of total exports value. This value was 17.3 percent and 55.1 percent higher than the previous quarter and the same quarter last year respectively.

Ignition wiring sets, other wiring sets for vehicles exports followed with a total value of \$9 million, accounting for 25.4 percent share of total exports value. This value was 29.5 percent and 16.1 percent higher than the previous quarter and the corresponding quarter of 2015 respectively.

Petroleum oils² other than crude oil exports was third with its value increasing to \$7.9 million from \$5.6 million in the previous quarter, contributing 22.2 percent of total exports value. In comparison with the June 2015 quarter, the current value of petroleum oils decreased 1.4 percent.

Fruit juices exports was fourth valued at \$2.6 million, representing 7.3 percent of total exports value, increasing 45.4 percent from the previous quarter and three times higher than the corresponding quarter of 2015, driven by higher values of nonu juice exports.

Coconut oil exports recorded a total value of \$1.1 million, accounted for 3.1 percent of total exports value. This value was seven times higher than the previous quarter and 14.3 percent higher than the corresponding quarter of 2015, reflecting higher values of exports to Malaysia.

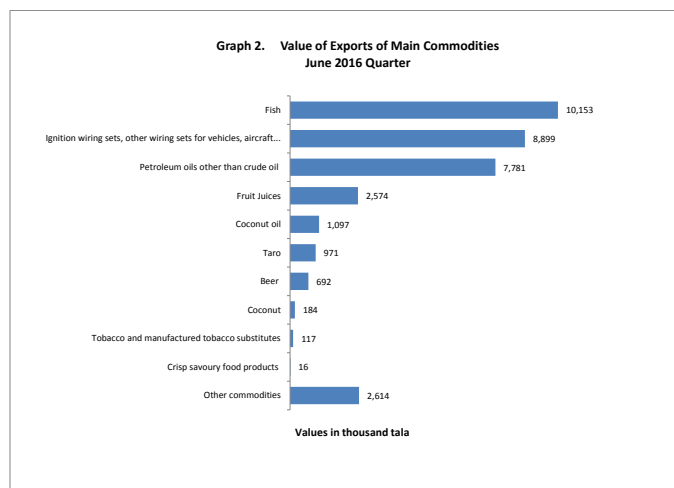
Taro exports were valued at \$971 thousand, representing 2.8 percent of total exports value, decreasing 34.1 percent and 3.1 percent from

the previous quarter and the same quarter of 2015 respectively.

Beer and coconut exports were also increased with total values of \$692 thousand (2 percent of total exports value) and \$184 thousand (0.5 percent of total exports value) respectively. Tobacco and crisp savoury exports were decreased with total values of \$117 thousand and \$16 thousand respectively while other export commodities valued at \$2.6 million, representing 7.4 percent of total exports value. Country of Destination for Exports

Australia maintained the largest export market in the June 2016 quarter with its value increasing to \$12.9 million from \$9.4 million in the previous quarter, representing 36.6 percent of total exports value. In comparison with corresponding quarter of 2015, the current value of exports to Australia increased 3.6 percent; driven by higher values of ignition wiring sets for vehicles exports.

Exports to American Samoa had a total value of \$8 million, accounting for 22.9 percent of total exports value, increasing 25.1 percent from the previous quarter and 50.7 percent from the same quarter last year; driven by higher values of fish exports.

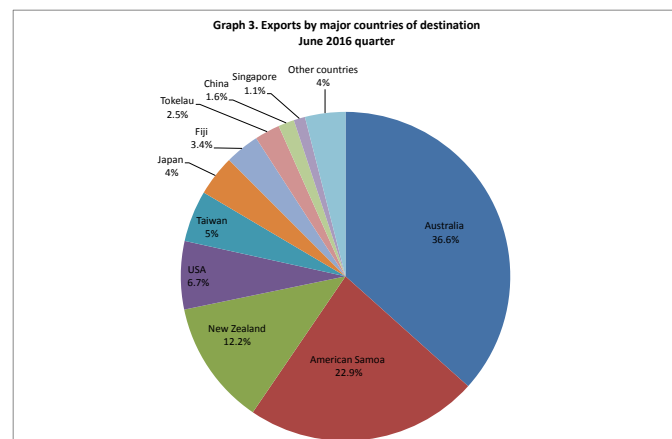
Exports to New Zealand were valued at \$4.3 million, accounting for 12.2 percent of total exports value, increasing 12.8 percent from the previous quarter but 7 percent lower than the corresponding quarter of 2015.

Exports to USA increased to \$2.4 million from \$2 million in the previous quarter, accounting for 6.7 percent of total exports value. In comparison with same quarter of 2015, the current value of exports to USA was three times higher.

Exports to Taiwan, Japan, Fiji and Singapore were also increased from the previous quarter, representing 5 percent, 4 percent, 3.4 percent and 1.1 percent of total exports value respectively.

Exports to Tokelau and China were decreased from the previous quarter, accounting for 2.5 percent and 1.6 percent of total exports value respectively.

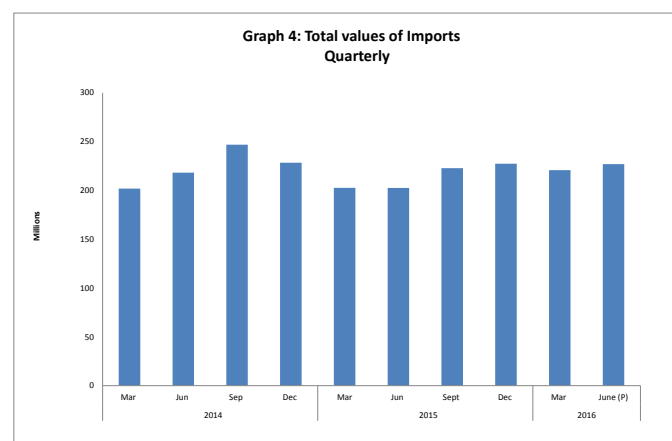
Other countries of destination represented 4 percent of total exports value. (See table 4 and graph 3)

Value of Imports

In the June 2016 quarter, imports were valued at \$227 million. This value was 2.8 percent higher than the previous quarter and 12.1 percent higher than same quarter of 2015. (See table 1 and graph 4)

The four quarters ending June 2016 showed an increase of 2 percent in the total value of imports compared with the four quarters ending June 2015.

Composition of Imports

In the June 2016 quarter, mineral products maintained the largest share of all commodity groups imported with a total value of \$38.5 million, contributing 17 percent of total imports. This value showed a slight increase of 0.03 from the previous quarter but 1.7 percent lower than the corresponding quarter of 2015.

Imports of machinery & mechanical & electrical appliances & parts thereof decreased to \$29.7 million from \$34.4 million in the previous quarter, accounting for 13.1 percent of total imports value. In comparison with the June 2015 quarter, the current value of machinery & mechanical & electrical appliances & parts thereof increased 42.7 percent.

Live animals and animal products imports recorded a total value of \$27.7 million, accounting for 12.2 percent of total imports value, increasing 51.9 percent from the previous quarter and 11.8 percent from the corresponding quarter of 2015.

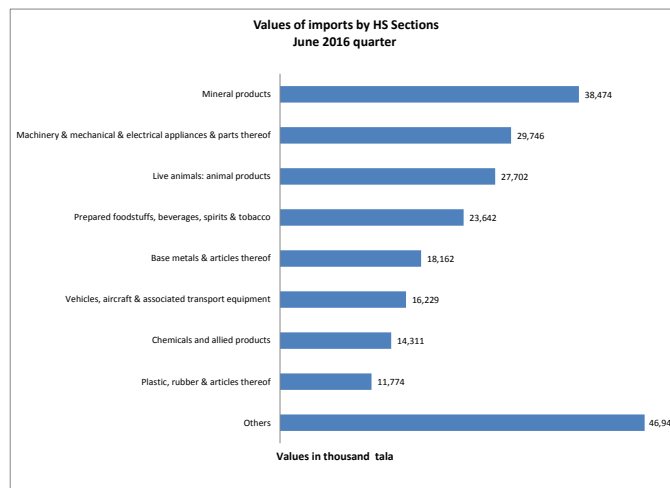
Prepared foodstuffs, beverages, spirits and tobacco imports were valued at \$23.6 million, representing 10.4 percent of total imports value, decreasing 2.1 percent from the previous quarter but 1.3 percent higher than the same quarter last year.

Imports of base metals and articles thereof products had a total value of \$18.2 million, accounting for 8 percent of total imports value, decreasing 7.5 percent from the previous quarter but 41.2 percent higher than the corresponding quarter of 2015.

Imports of vehicles, aircraft and associated transport equipment had a total value of \$16.2 million, accounting for 7.1 percent of total imports value, increasing 22.2 percent from previous quarter.

Chemicals and allied products imports valued \$14.3 million, accounting for 6.3 percent of total imports value, increasing 2.1 percent and 12.6 percent from the previous quarter and the corresponding quarter of 2015 respectively.

Imports of plastic, rubber and articles thereof had a total value of \$11.8 million, decreasing 10.3 percent and 13 percent from the previous quarter and the same quarter of 2015 respectively, representing 5.2 percent of total imports value while the remaining HS Sections accounted for less than 5.0 percent each with a combined total of \$46.9 million, representing 20.7 percent of total imports. 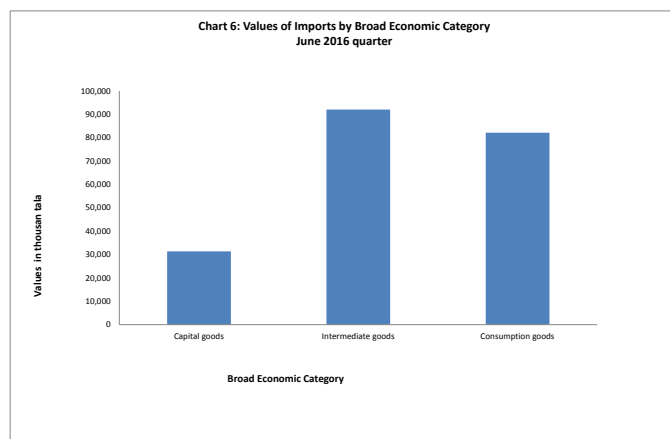

Imports by Broad Economic Categories

For the three main broad economic categories in the June 2016 quarter, capital goods were valued at \$31.4 million, accounting for 13.8 percent of total imports value, increasing 35.7 percent from the previous quarter.

Intermediate goods were valued at \$92.1 million, accounting for 40.6 percent of total imports value, decreasing 10.5 percent from the previous quarter

Consumption goods were valued at \$82.1 million, accounting for 36.2 percent of total imports value, increasing 10.8 percent from the previous quarter. (See table 6 and graph 6)

Major Source Markets of Imports

By major source markets of imports, New Zealand continued to be the leading source market of imports in the June 2016 quarter, contributing 27.4 percent of total imports value, increasing 11.6 percent and 8.6 percent from the previous quarter and the same quarter last year respectively.

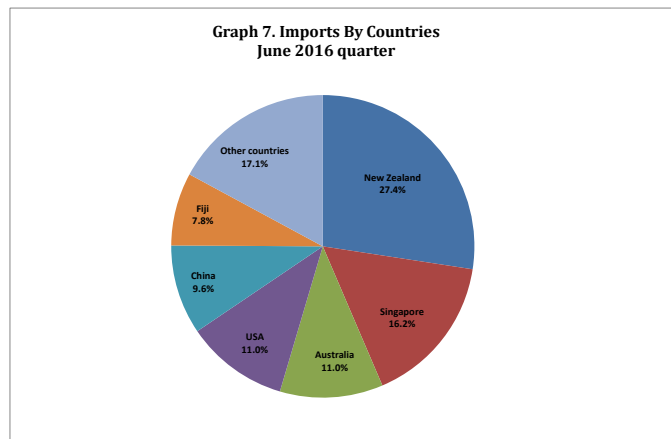
Imports from Singapore accounted for 16.2 percent of total imports value, increasing 6.8 percent from the previous quarter and 4.2 percent from the corresponding quarter of 2015.

Imports from Australia and USA accounted for 11 percent each of total imports value. Imports from Australia increased 10.9 percent and 3.8 percent from the previous quarter and the same quarter last year respectively. Imports from USA increased 22.1 percent and 1.9 percent from the previous quarter and the corresponding quarter of 2015 respectively.

Imports from China accounted for 9.6 percent of total imports value, decreasing 31.6 percent and 9.1 percent from the previous quarter and the corresponding quarter of 2015 respectively.

Imports from Fiji accounted for 7.8 percent of total imports, increasing 13.8 percent from the previous quarter and 29.3 percent from the corresponding quarter of 2015 quarter.

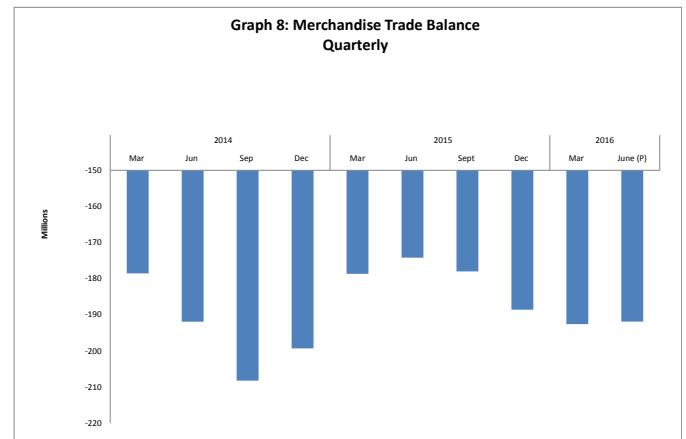
All other countries of imports accounted for less than 5.0 percent each with a combined total of 17.1 percent. (See table 7 graph 7).

Merchandise Trade Balance

In the June 2016 quarter, the value of imports (\$227 million) exceeded that of exports (\$35 million), resulting in a trade deficit of \$192 million. (See table 1 and graph 8)

Technical Notes

The main source of imports and exports data comes from the administrative document, a completed customs form (Single Administrative data) required to be filled in by importers and exporters or customs agents when clearing merchandise inward and outward through the Ministry for Revenue (Custom Department)

Definitions

June 2016 quarter: (April, May, June 2016)

Capital goods: are produced assets that are used repeatedly or continuously, for longer than one year, in industrial production processes. Examples are machinery, trucks, and aircraft.

cif: is the cost of goods, including insurance and freight to Samoa.

Consumption goods: are goods used (without further transformation in industrial production processes) by households, government, or non-profit institutions serving households.

Exports (including re-exports): are goods of domestic origin exported from Samoa to another country. Exports in this release are valued fob and are shown in Samoan tala.

fob: is free on board (the value of goods at Samoa ports before export).

Imports: are goods imported into Samoa. Imports in this release are valued at cif and are shown in Samoan tala.

Intermediate goods: are goods used up, or transformed in, industrial production processes.

Merchandise trade: covers exports or imports of goods that alter the nation's stock of material resources.

Provisional: statistics for the latest three months are provisional, to allow late data and amendments to be included.

Re-exports: are exports of foreign goods which were previously recorded as Samoa's imports.

Trade balance: is calculated by deducting imports (cif) from exports (fob). These two valuations are not entirely comparable, because the cif valuation includes insurance and freight to Samoa, while the fob valuation excludes insurance and freight from Samoa.

Trade deficit: occurs when the value of imports is more than the value of exports.

Trade surplus: occurs when the value of exports is more than the value of imports.
