

1. TOTAL ARRIVALS


Fig. 1: May Total Arrivals, 2006 - 2017

The total International Arrival Statistics recorded for the month of <u>May 2017</u> (table 1), revealed an increase of 0.6 percent over the previous month and an increase of 4.8 percent over the corresponding month of May 2016. (Refer Fig. 1)

Air was the preferred mode of travel to Samoa, representing 96.1 percent (15,152) of total arrivals, while the remaining 3.9 percent (919) arrived by sea in May 2017.

2. TOTAL VISITORS

Overall Visitors numbered 11,025 for the month under review revealed a decrease of 5.0 percent over the previous month and a decrease of 2.0 percent when compared to the corresponding month of May 2016. (Refer Fig. 2).

Fig. 2: May Total Visitors, 2006 - 2017




Visitor arrivals have a strong seasonal pattern with a regular peak of numbers during holiday seasons normally from December to January. The smoothed short-term trend for visitor arrivals adjusting for seasonal pattern is shown in Appendix Graph 2.

3. TOTAL ARRIVALS BY PURPOSE OF ENTRY

Visitors, including transit, made up the largest component of all arrivals with 34.8 percent (5,638) being males and 32.0 percent (5,176) being females.

Male returning residents made up 19.4 percent (3,146) of total arrivals while their female counterpart made up 12.5 percent (2,027). (Refer Fig. 3)

Fig. 3: Total Arrivals, by Purpose of Visit




4. VISITORS BY COUNTRY OF USUAL RESIDENCE

New Zealand remains as the leading country in visitors' arrival by country of usual residence (Table 3) accounting for 45.9 percent or 5,062 of total visitors. Australia followed next with a distant 21.3 percent share (2,350).

American Samoa represented 11.1 percent (1,219) while the United States of America represented 7.3 percent (802) of total visitors. (Refer Fig. 4)

Fig. 4: Total Visitors, by Country of Usual Residence




5. VISITORS BY REGION

The Oceanic Region had the highest share of total visitors with 82.9 percent, followed by America with 7.4 percent.

Asia reported a share of 4.7 percent while Europe reported the least share with 2.9 percent. (Refer Fig. 5).

Fig. 5: Total Visitors, by Region




6. VISITORS BY PURPOSE OF VISIT

The principal source markets (table 4) namely New Zealand, American Samoa, Australia, and the United States of America constitute 85.6 percent of all visitors visiting Samoa in May 2017.

The majority of visitors (34.8 percent) entered our shores for holiday/ vacation while 28.3 percent entered our shores to visit friends/ relatives while.

Those who were here for Business/ Conference made up 12.9 percent while those who were here on Transit recorded a share of 9.0 percent. Fig.6 depicts total visitors by purpose of visit for May 2016 and May 2017.

7. TOTAL ARRIVALS BY CARRIER

As depicted in table 5, Virgin Samoa leads the way of arrival by carriers' during the reference period with a 33.7 percent share (5,460 passengers) followed by Air New Zealand with a 29.2 percent share (4,725 passengers).

Polynesian Airlines brought in 16.7 percent (2,698) of total arrivals while Fiji Airways, formerly known as Air Pacific, recorded a share of 7.6 percent (1,239). Fig. 7 illustrates total arrivals by carrier during the reference period.

Fig. 7: Total Arrivals by Carrier





Fig. 8: Total Visitors by Duration of Stay



As shown in Fig. 8 above, visitor's duration of stay in Samoa (Table 6) is between seven and thirty days.

The majority of visitors (55.4 percent or 5,562 visitors) reported staying in private accommodation or with families/ relatives while 41.2 percent (4,130) stayed in hotels/ motels. The remaining 3.4 percent or 343 visitors did not state their place of stay. (Refer Fig. 9).

Fig. 9: Total Visitors by Place of Stay





Fig. 10 portrays the number of visitors who stayed in hotels/motels (3,001) by type of accommodation (hotel/motel), within the reference month.

- (3) Apia Wharf (Matautu Port)


International arrival statistics are compiled on a monthly, quarterly and annual basis. These reports can also be extracted from our website: www.sbs.gov.ws

The migration report for the month of June 2017 will be released indefinitely due to other official commitments by the relevant staff.



Graph 3: Visitors Percentage Change over Previous month, May 2012 - May 2017


