IMPORT PRICE INDEX - September 2017 Quarter (Base Period: March 2009 quarter = 100.0)

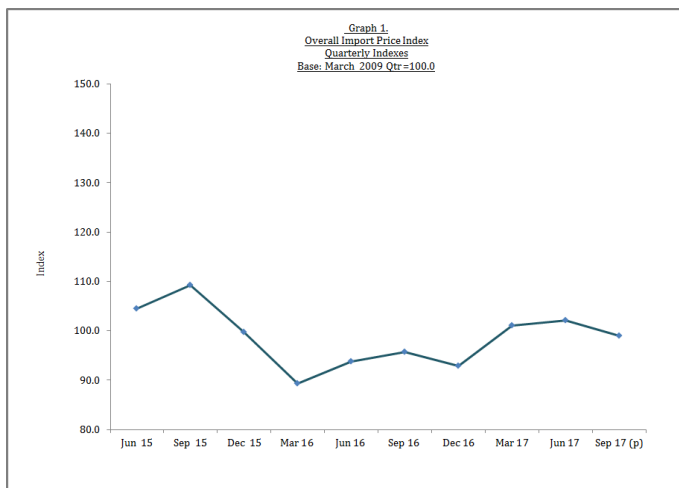
Highlights of the quarter

- Import Price index fell 3.1 percent from the June 2017 quarter.
- Mineral Products index recorded the largest decrease (down 8.4 percent).

Overview

The Import Price Index for the September 2017 quarter showed an overall decrease of 3.1 percent from the June 2017 quarter. Mainly responsible for the decrease was lower prices for mineral products. In comparison with the September 2016 quarter, the current import price index rose 3.3 percent.

The four quarters ending September 2017 showed a 4.4 percent increase in the overall import price index compared with the four quarters ending September 2016 quarter. See table 1 and graph 1.

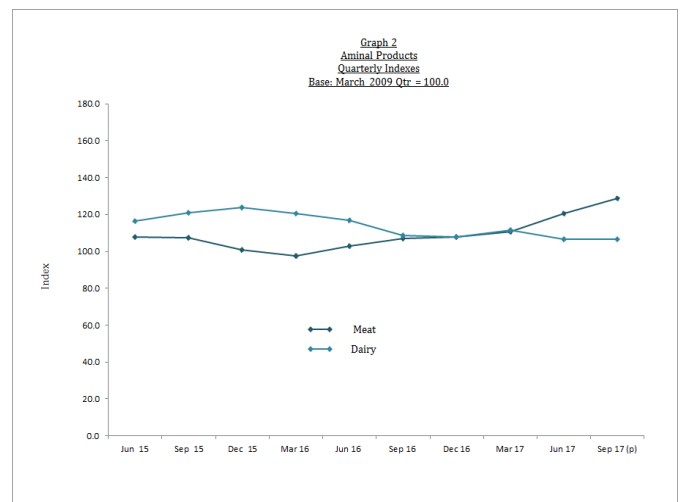

HS Section 1: Live Animals; Animal Products prices rise 4.8%.

Import prices for Live Animal Products in the September 2017 quarter rose 4.8 percent, following the 5.2 percent rise in the June 2017 quarter. The current increase was led by higher prices of meat products, reflecting higher prices of sheep meats (up 5.2 percent) and poultry meats (up 8.4 percent). In comparison with the September 2016 quarter, the current live animals and animal products index increased 14.0 percent.

Reviewing the four quarters ending September 2017 over the four quarters ending September 2016, the current overall animals and animal products index increased 7.5 percent. See tables 1 & 2 and graph 2.



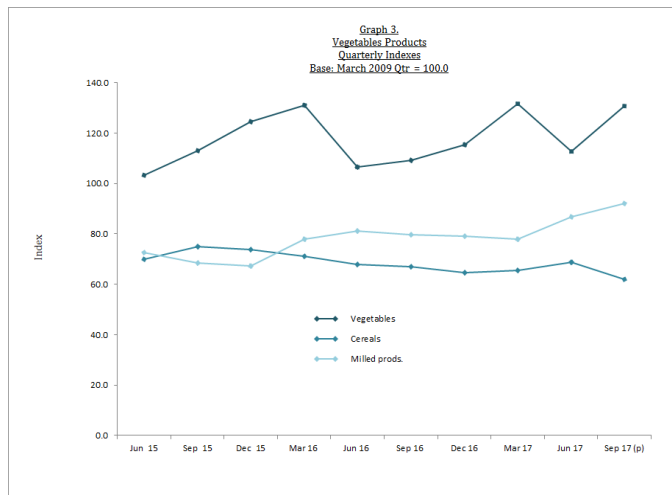

HS Section 2: Vegetable Products prices rise 4.2%.

Import prices for Vegetable Products rose 4.2 percent in the September 2017 quarter, following a 3.0 percent rise in the June 2017 quarter. The current rise was influenced by

higher prices of vegetable products (up 16.0 percent) reflecting higher prices of potatoes. Prices for milled products also increased (up 6.0 percent). In comparison with the September 2016 quarter, the current vegetables products index increased 10.3 percent.

Reviewing the four quarters ending September 2017 over the four quarters ending September 2016, the current overall vegetable products index increased 3.8 percent. See tables 1 & 2 and graph 3.

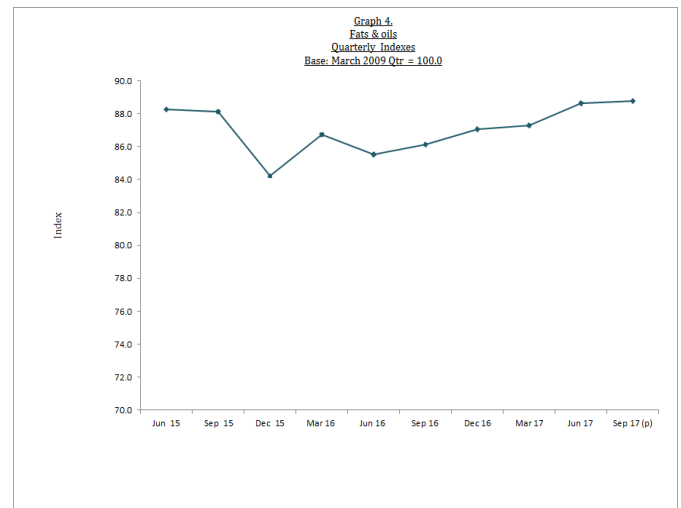

HS Section 3: Animal or Vegetable fats & oils prices rise 0.2%.

Animals or Vegetable fats and oils import prices rose 0.2 percent in the September 2017 quarter, following a 1.5 percent rise in the June 2017 quarter. The current rise was influenced by higher prices of margarine (up 3.1 percent). When compared with the September 2016 quarter, the current animal or vegetable fats and oils index increased 3.1 percent.

The four quarters ending September 2017 showed a 2.7 percent increase in the overall animal or vegetable fats and oils index over the four quarters ending September 2016. See tables 1 & 2 and graph 4.

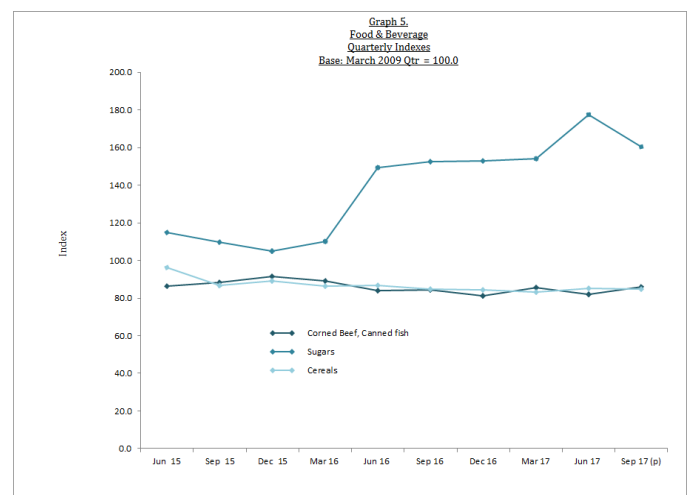

HS Section 4: Food and Beverages prices fall 2.3%.

Food and Beverage import prices fell 2.3 percent in the September 2017 quarter, following a 4.5 percent rise in the June 2017 quarter. The fall over the previous quarter mainly driven by lower prices of sugar (down 9.7 percent). In comparison with the September 2016 quarter, the current food and beverages index increased 2.5 percent.

When comparing the four quarters ending September 2017 with the four quarters ending September 2016, the current overall food and beverages index increased 5.5 percent. See tables 1 & 2 and graph 5.



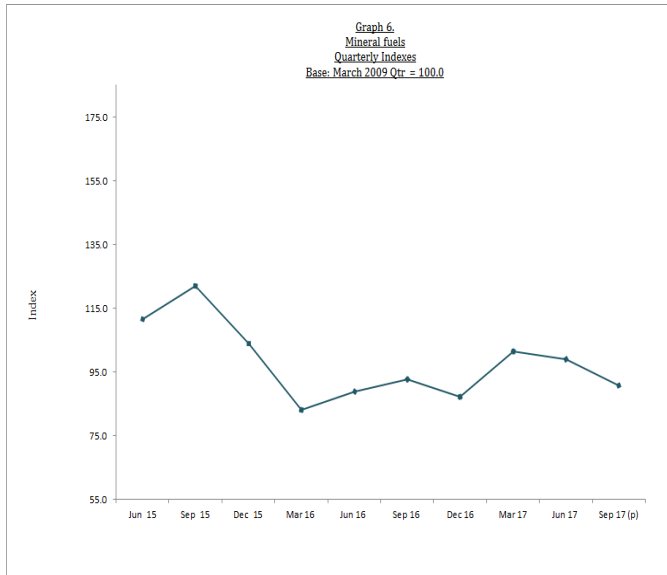

HS Section 5: Mineral Products prices fall 8.4%.

Import Price for Mineral Products fell 8.4 percent in the September 2017 quarter, following the 2.5 percent fall in the June 2017 quarter. In comparison with the September 2016

quarter, the current mineral products index decreased 2.2 percent.

The overall mineral products index in the four quarters ending September 2017 was 2.7 percent higher when compared with the four quarters ending September 2016. See tables 1 & 2 and graph 6.

Technical Notes

The Import Price Index (MPI) measures changes in the cost, insurance, and freight (CIF) prices of imports of merchandise into Samoa. It is a fixed weight index with March 2009 quarter = 100.0 and is calculated on a quarterly basis using the International Harmonized System of Trade Classification (HS). The items included in the index were selected on the basis of their importance to the total import.

The scope of the MPI relates to the following sections of the International Harmonized System of Trade Classification (HS): 1. Live Animals: Animal Products, 2. Vegetable Products, 3. Animal or Vegetable fats and oils, 4. Food and Beverages and 5. Mineral Products, The index represents 50 percent of total Imports.


