Merchandise Trade October 2018

Highlights of the month

October 2018 compared with September 2018

Exports¹

- ✚ The total value of merchandise exports increased 44.6 percent to \$16.8 million in October 2018.
- ✚ Exports of 'Miscellaneous Manufactured goods' had the largest increase in values of all commodity groups (up \$2 million) exported in October 2018.
- ✚ 'Food and Live animals' exports remained the top commodity groups exported in October 2018, accounting for 53.1 percent of total exports value.
- ✚ Exports to Tokelau recorded the largest increase in value (up to \$4 million) in October 2018.

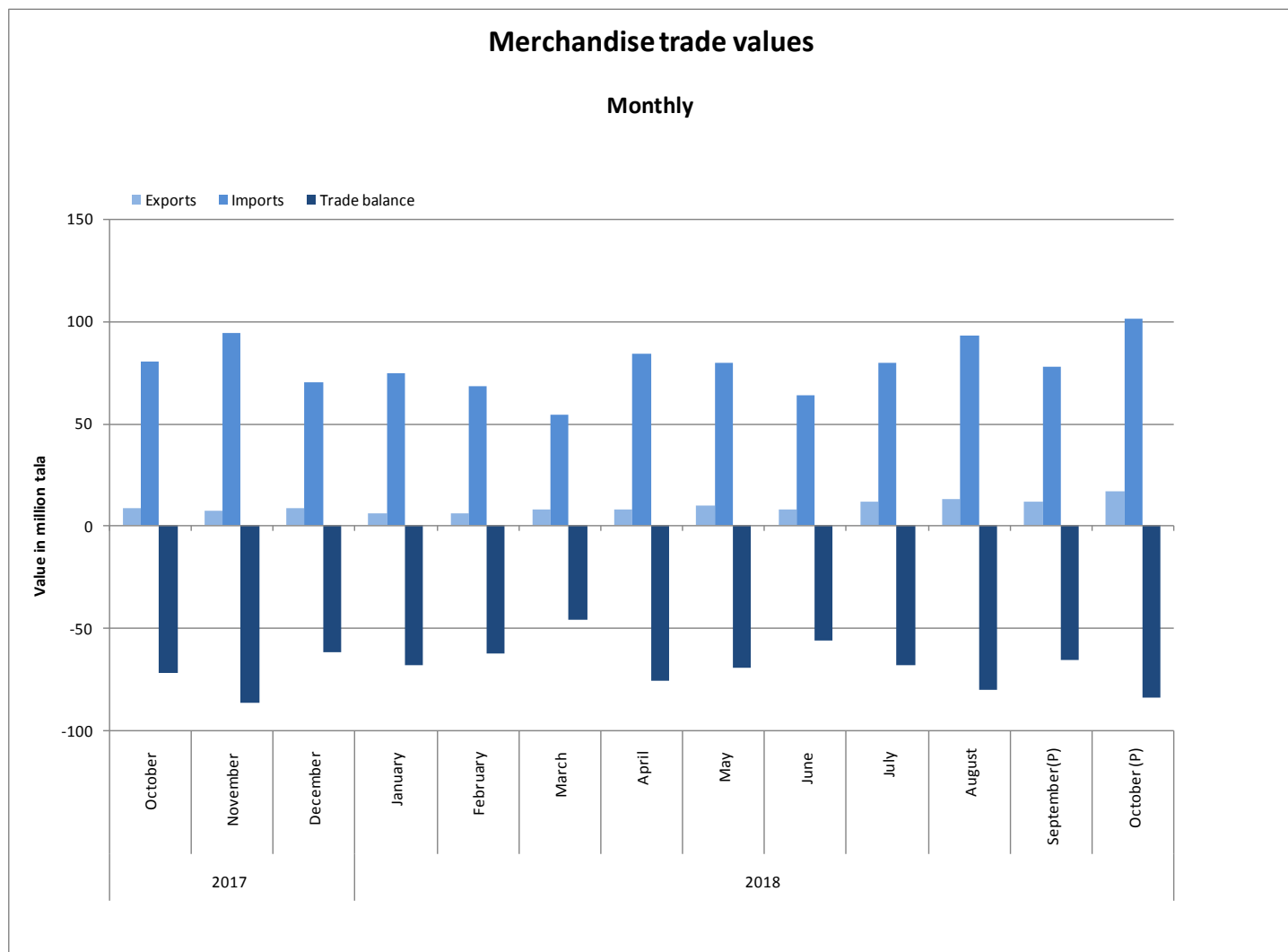
Imports

- ✚ The total value of merchandise imports increased 30.4 percent to \$100.9 million in October 2018.
- ✚ 'Food and Live animals' imports recorded the largest increase (up \$8 million) and became the top commodity groups imported in October 2018, accounting for 26.1 percent of total imports value.
- ✚ Imports from China, New Zealand and Australia recorded largest increases in values in October 2018.

Trade Balance

- ✚ The total value of imports (\$100.9 million) exceeded that of exports (\$16.8 million), resulting in a trade deficit of \$84.1 million.

The main source of imports and exports data comes from the administrative document; a completed customs form (Single Administrative data-SAD) which is required to be filled in by importers and exporters or customs agents when clearing merchandise inward and outward through the Ministry for Revenue (Custom Department)
