
Mission:

- Samoa Strategy for the Development of Statistics approved in August 2012
- New Statistics legislation approved to bring legislative framework up-to-date
- Organisation structure improved with establishment of IT Division, appointment of HR and web-master positions & increase in statistical positions
- Human Resource Management, HR Development Plan & Performance Management Systems developed and documented
- Corporate Planning Guidelines developed & used in preparing 2012 -2016 SBS Corporate Plan
- Records management systems reviewed & changes being implemented
- Corporate services operational guidelines compiled & available for staff
- Training in leadership and management for all senior staff
- Training and capacity building programme instituted for all staff

Statistical Services Economic & Finance Statistics

- □ CPI rebased using 2011 Census and 2008 HIES
- Trade data compilation updated with new PCTrade software and trade data reporting improved
- National accounts rebasing to 2009 base-year; almost complete
- Government Finance Statistics upgraded from 1985 to 2001 (current) international best practice
- 2013/14 Household Income and Expenditure Survey currently being undertaken
- Development of comprehensive Business Survey Framework underway in cooperation with MCIL
- Handbook/guidelines now available on economic statistics linking national accounts, trade, CPI & GFS data to support capacity building of staff
- Statistical methodologies and processes strengthened and improved, supported by capacity building for staff

- Census/survey methodologies and processes strengthened and improved; including use of scanning, GPS, & mapping
- Migration data reporting, compilation & analysis improved and trends better understood

- Release dates for statistics published on web-site in advance for information of users
- Style Guide introduced and being used in the compilation of statistical reports
- Statistical Abstract expanded, redesigned & published; including new indicators
- Extensive training program ongoing focusing on improving reporting, writing and analysis skills of staff in all Divisions

Statistics IT Systems and Processes

- IT Division established; ACEO IT & Web-master appointed
- Five year IT Strategy developed and being implemented
- New IT equipment and software procured & installed; including BDM Apia & Savaii offices
- BDM software upgraded
- Improvements to SBS web-site
- Capacity building ongoing through formal and informal training & attachments

Way Forward

- HIES to be completed and results published in 2014
- Labour Force Survey results to be published in 2014
- DHS scheduled for 2014
- Business Activity Framework & Survey planned for 2014/15
- Next Population Census scheduled for 2016
- All operational manuals and guidelines to be maintained and used as training tools for all staff
- Research & Analysis capacity in SBS to be established to strengthen dissemination, outreach and use of statistics by stakeholders
- SSDS to be reviewed and updated
- Training and capacity building to be continued for staff development



Way Forward

- Additional TA resources will continue to be needed for specialist technical tasks & analysis; e.g. to assist in carrying-out:
 - CPI weights update from 2013 HIES
 - Poverty/ hardship and vulnerability analysis from 2013/14 HIES
 - Development of Environmental Accounts
 - Extension of GDP indicators and development of other short term economic lead indicators
- More modern, flexible system for BDM registration to be initiated within the next five years;
 - new system to be integrated with the developments in the health management information system so that information can flow easily between the health and BDM systems.
